## INTRODUCTION:

The Canadian Association of Research Ethics Boards/ L'Association canadienne des comités d'éthique de la recherche (CAREB-ACCER) is a grassroots national membership organization intended to represent the interests of all Canadian Research Ethics Boards ("REBs") and to reflect REB perspectives and concerns. The CAREB-ACCER Board of Directors ("BOD") has made a commitment to engage in cultural competency training and make accessible to its membership and the broader Canadian research ethics community, cultural competency training with an initial focus on anti-Black racism and equity education in support of its efforts to dismantle existing systems of oppression within the Canadian research ethics sector (the "Initiative").

## OBJECTIVE

As a national research ethics organization with a vision to: (1) promote professionalism through the sharing of expertise, experience, information and knowledge; (2) represent and communicate the perspectives and concerns of Research Ethics Board (REB) professionals in local, national and international policy development and implementation; and (3) provide education and resources needed to successfully promote the ethical conduct of research CAREB-ACCER is obligated to be part of leading the change in the Canadian Human Research Ethics field as it relates to Anti-Black Racism. In order to do this CAREB-ACCER, has embraced the important concepts of:

1. Accountability, specifically individual and organizational accountability; and

2. Learning

through this Initiative.

## **RATIONALE & PURPOSE**

Through a focus specifically on anti-Black racism, and a commitment to unlearning our own biases and minimizing our role in reinforcing systems of oppression CAREB-ACCER is equipped to lead the charge in the Canadian Human Research Ethics field as it relates to addressing anti-Black racism and all forms of racism and prejudice within the research ethics field.

Our focus on anti-Black racism is an important distinction given the absence of discussion, action and focus on this issue in the broader area of diversity and anti-oppression work in the Canadian Human Research Ethics space. With the work we have begun in our own learning and unlearning, the under representation of this issue in the Canadian research ethics context (both content and education) and our national and international reach, we are committed to addressing anti-Black racism. Through this work we strive to be an enabler in solving a lot of the systemic issues that affect populations that are victims of racism, oppression and prejudiced systems in the Human Research Ethics space through education, awareness and action. As a national organization and leader in research ethics, it is critical that we enable and encourage anti-Black racism discussions, education and action to equip research ethics boards and researchers on how to approach research with an equitable and diverse lens (the "Purpose").

## SCOPE OF WORK

This RFQ is being issued to obtain quotations for the design, development and delivery of anti-Black racism research ethics discussion and education series for the Canadian Research Ethics community in alignment with the Purpose.

The successful proponent(s) is expected to:

 Design and develop a series of anti-Black racism education sessions relevant to the Canadian research ethics context that integrates the ethical principles within the Canadian Institutes of Health Research, Natural Sciences and Engineering Research Council of Canada, and Social Sciences and Humanities Research Council, Tri-Council Policy Statement: Ethical Conduct for Research Involving Humans, December 2018 (TCPS2) and creates a safe space to learn, discuss and consider the connections between intersectionality, the research process, and ethics as it relates to anti-Black racism ("Anti-Black Racism Research Ethics Educational Series"). 2. Deliver the Anti-Black Racism Research Ethics Educational Series content through a CAREB-ACCER secure platform.

## The Deliverables

Deliverable 1: Completion and delivery of the first educational session in alignment with the Purpose.

Deliverable 2: Completion and delivery of the second educational session in alignment with the Purpose.

Deliverable 3: Completion and delivery of the third educational session in alignment with the Purpose.

Deliverable 4: Completion and delivery of the fourth educational session in alignment with the Purpose.

Deliverable 5: Completion and delivery of the fifth educational session in alignment with the Purpose.

## APPROACH & BUDGET LIMIT

This RFQ is open to a collaborative multi-proponent award approach in which one vendor may execute on certain deliverables and another vendor(s) executes on the remaining deliverable(s). Funding for this work was secured through a federal Secretariat on the Responsible Conduct of Research Education and Training Support (SETS) grant awarded to CAREB-ACCER. The budget allotted for this work (series of 5 sessions) is \$7,500.00. Proponent's proposal may outline an alternate approach for educational content delivery (e.g. alternate number of sessions). If a proponent cannot commit to all deliverables within the stated budgetary allotment, consideration will be given to alternate pricing proposed by a proponent for the full scope of work.

## **Clarification and Questions**

The deadline for submitting clarifications and questions is May 14, 2021 at 10:00 PM EST. Proponents may request clarification of this RFQ by submitting all requests by email to president@careb-accer.org.

## **Questions and Answers**

CAREB-ACCER will provide proponents with written responses to questions that are submitted in writing. Questions and answers will be distributed in numbered addenda to proponents that have submitted a quotation or a notice of intention to submit a quotation. All addenda shall form part of this RFQ. In answering the proponent's questions, CAREB-ACCER shall include in the addenda all questions but not attribute the questions to any proponent.

## Notification to Other Proponents of Award

Once an agreement is executed between the successful proponent(s) and CAREB-ACCER, the other proponents will be notified by CAREB-ACCER in writing of the award of the contract to the successful proponent.

## Clarification of Proponent's Quotation

CAREB-ACCER shall have the right at any time after quotation submission to seek clarification from any proponent in respect of that proponent's quotation, without contacting other proponents. In the clarification process, no change in the substance of the quotation will be offered or permitted. Subject to the qualification in this section, any written information received by CAREB-ACCER from a proponent in response to a request for clarification from CAREB-ACCER shall be considered part of the proponent's quotation.

#### Pricing

Prices should be quoted in Canadian dollars. Prices shall not be subject to adjustment for fluctuations in foreign exchange rates. All prices quoted, unless otherwise instructed in this RFQ, shall remain firm for the period set out in the quotation and in the subsequent agreement put in place with the successful proponent(s). All prices should be quoted exclusive of the goods and services tax and federal or provincial taxes or other similar taxes, each of which, if applicable, should be stated separately.

## **TERMS AND CONDITIONS**

#### **Confidentiality**

CAREB-ACCER acknowledges and anticipates the disclosure of information may be confidential and/or proprietary to the proponent(s) on a confidential bases for the purpose of this RFQ process. CAREB-ACCER will maintain in confidence any confidential and/or proprietary information of the proponent(s) that it receives during this RFQ process, and not to disclose or use such information other than in connection with its activities in running this RFQ process, and the Initiative.

## Ownership and Disclosure of Quotation Documentation

The documentation comprising any quotation submitted in response to this RFQ, along with all correspondence, documentation and information provided to CAREB-ACCER by any proponent in connection with, or arising out of this RFQ, once received by CAREB-ACCER shall become the property of CAREB-ACCER and may be appended to the agreement executed with the successful proponent(s).

#### Conflict of Interest

The proponent shall not have any actual or potential conflict of interest or any other type of unfair advantage in submitting its quotation, except to the extent any such conflict of interest or unfair advantage are set out in the quotation.

CAREB-ACCER shall not be liable to any proponent, person or entity for any losses, expenses, costs, claims or damages of any kind:

- a. Arising out of or by reason of or attributable to the proponent responding to this RFQ
- b. As a result of the use of any information, error or omission contained in this RFQ document, provided during the RFQ process; and

c. Which may occur between quantities of work actually done or supplied and the estimated quantities set out in this RFQ.
